## PRESIDING JUDGE ERIC C. TAYLOR ANNOUNCES NEW GENERAL ORDER EXTENDING CERTAIN JUVENILE DEADLINES

Presiding Judge Eric C. Taylor today announced a new General Order extending certain Juvenile deadlines through January 28, 2022. The General Order is issued under the authority granted by Chief Justice Tani G. Cantil-Sakauye.

The Order, which is attached, extends deadlines as follows:

## Juvenile Dependency

(i) The time periods provided in section 313 of the Welfare and Institutions Code within which a minor taken into custody pending Dependency proceedings must be released from custody to not more than seven (7) days, applicable only to minors for whom the statutory deadline would otherwise expire from January 1, 2022, to January 28, 2022, inclusive; and
(ii) The time periods provided in section 315 of the Welfare and Institutions Code within which a minor taken into custody pending Dependency proceedings must be given a detention hearing to not more than seven (7) days, applicable only to minors for whom the statutory deadline would otherwise expire from January 1, 2022, to January 28, 2022, inclusive.

## GENERAL ORDER 2-2-2-2

The Order also states that in accordance with <u>General Order 2021-GEN-023-00</u>, all persons – regardless of vaccination status – are required to wear face coverings over their nose and mouth while in a courthouse. Persons whose disabilities preclude them from wearing face coverings compliant with the guidance are urged to seek an accommodation under <u>Rule 1.100</u> of the California Rules of Court in advance of their court appearance or appointment. Persons seeking services from the Clerk's Office, court support services, and/or the Self-Help Centers are encouraged to schedule appointments and use the available online services. For telephone or video assistance, or <u>to schedule an appointment</u>, the telephone number for each courthouse is listed at the courthouse entry and posted on the Court's website, <u>www.lacourt.org</u>.

Presiding Judge Taylor also strongly encourages litigants and attorneys to appear remotely for their hearing using the Court's LACourtConnect system. To register to appear remotely, visit <u>lacourt.org/lacc/</u> to learn more and start the registration process. Video appearances are strongly encouraged.

a. Juvenile Dependency

- i. The Court extends the time periods provided in section 313 of the Welfare and Institutions Code within which a minor taken into custody pending dependency proceedings must be released from custody to not more than seven (7) days, applicable only to minors for whom the statutory deadline would otherwise expire from January 1, 2022 to January 28, 2022, inclusive.
- ii. The Court extends the time periods provided in section 315 of the Welfare and Institutions Code within which a minor taken into custody pending dependency proceedings must be given a detention hearing to not more than seven (7) days, applicable only to minors for whom the statutory deadline would otherwise expire from January 1, 2022 to January 28, 2022, inclusive.

THIS ORDER IS EFFECTIVE IMMEDIATELY AND WILL REMAIN IN EFFECT UNTIL FURTHER NOTICE, OR UNTIL ITS PROVISIONS EXPIRE BY THEIR TERMS, ARE RESCINDED, AMENDED, OR ARE SUPERSEDED BY SUBSEQUENT ORDERS. THIS ORDER MAY BE AMENDED AS CIRCUMSTANCES REQUIRE. GOOD CAUSE APPEARING THEREFOR, IT IS SO ORDERED.
